Your vehicle is a major investment, so the last thing you want to think about is having your vehicle stolen. However, today's car owner simply cannot afford to ignore the possibility.

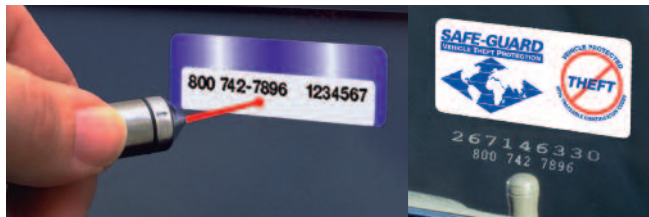
## The Facts.

- Approximately every 40 seconds, a vehicle is stolen in the United States.\*
- A professional car thief can steal a vehicle in less than one minute.

- Your insurance company generally covers only the vehicle value at the time of the loss, leaving you responsible for deductibles plus the replacement vehicle's taxes, fees and down payment.

## The Protection.

- Traceable security codes are permanently installed on various parts of your vehicle and recorded in a database accessible by law enforcement agencies.
- These codes along with distinctive anti-theft warning decals make vehicles less desirable to experienced car thieves.
- A financial warranty benefit of up to \$5,000 is provided to help you defray the costs of having a vehicle stolen and declared a total loss.



Safe-Guard's Theft Protection systems permanently mark the vehicle's body parts or etch the glass with indelible identification numbers, which are registered in a database that can be scanned by law enforcement officials to trace the vehicle's ownership.

## The Numbers.

Safe-Guard Theft Protection provides you with vehicle and financial security. Unfortunately, your insurance may not cover all of the costs associated with a loss due to the theft, leaving you responsible for deductibles plus the replacement vehicle's taxes, fees and down payment.

**The following are the typical out-of-pocket expenses not covered by your insurance company:**

1. Replacement Vehicle Costs (down payment, sales tax and miscellaneous fees)		\$1,000 – \$2,000*
2. Deductibles	+	\$250 – \$1,000*
3. Payoff Deficiencies	+	\$1,000 – \$2,000*
